NRSC Withdraw and Refund Policy

Competitive soccer is a team sport, and travel teams are formed around the players who registered with the NRSC. After a team has been formed and rosters have been announced, the NRSC will follow through with its commitment and proceed on behalf of each team with coaching assignments, league registrations, player registrations, practice and game scheduling, etc.

Accordingly, the NRSC expects that players/parents will do the same on their end and will follow through with payment and any other obligations in a timely manner. Because withdrawals can result in the unraveling of a team, the policy regarding withdraw is stringent and not negotiable.

This withdraw process will formally have the player removed from the roster, discontinue his/her commitment to the NRSC, and discontinue any further financial obligation for the upcoming season. The NRSC has a limited refund policy. <u>All refund requests must be made in writing to the NRSC Board</u>. <u>Email is an acceptable method of communicating the intent to withdraw</u>.

The NRSC is a non-profit youth sports organization. NRSC members are responsible for paying fees until the time the NRSC receives the written intent to withdraw. Fees are collected for travel league registration and league fees, insurance, facility maintenance and upgrade costs, coaching education, licensure, and fees, credit card processing fees, equipment and uniform orders, and administrative costs.

All registration fees, late fees, and assessed processing fees must be paid in full in order for current or future participation in NRSC practices, games, skill sessions, and player evaluations.

Travel Program Policy

Refunds may be given under the following circumstances ONLY:

- The written notification of intent to withdraw must be submitted to the NRSC Board within seven (7) calendar days from the formal announcement of team rosters to receive a refund of registration fees minus any fees incurred by the club.
- Written notifications of intent to withdraw received by the NRSC Board after seven
 (7) calendar days of roster placement, but before the first training session may be subject to a \$75 processing fee.
- No refunds will be issued after the first training session of the season.

 Injured player: Members must provide a written notification of intent to withdraw due to injury to the Board with a corresponding doctor's letter prohibiting participation. Refunds will be prorated and may be subject to a processing fee.

Refundable Fees

- NRSC season registration fees may be refunded per the NRSC policies less applicable fees. Refunds are subject to a \$75 processing fee.
- If the NRSC cannot place a player on a team, a 100% refund of the registration fee will be granted.
- Please allow 30 days for processing.

Non Refundable Fees

- · Late fees are not refundable.
- ALL refunds may be subject to a \$75 processing fee. The processing fee is not refundable.
- No refunds will be issued if the intent to withdraw is received by the Board after the first training session of the season.
- Registration fees are not refundable in the event games or practices are cancelled for any reason (i.e. weather) or if a team fails to participate in a scheduled event for any reason.
- Registration fees are not refundable if a player is dismissed from a game or the NRSC for any reason.

Rec. and Munchkin Program Policy

Refunds may be given under the following circumstances ONLY:

- The written notification of intent to withdraw must be submitted to the NRSC
 Board to receive a refund of registration fees minus any fees incurred by the club.
- Injured player: Members must provide a written notification of intent to withdraw due to injury to the Board with a corresponding doctor's letter prohibiting participation. Refunds will be provided minus any fees incurred by the club.

Refundable Fees

- NRSC season registration fees may be refunded per the NRSC policies. Refunds are subject to a processing fee.
- · Please allow 30 days for processing.

Non Refundable Fees

- · Late fees are not refundable.
- ALL refunds may be subject to a processing fee. The processing fee is not refundable.
- Registration fees are not refundable in the event games or practices are cancelled for any reason (i.e. weather) or if a team fails to participate in a scheduled event for any reason.
- Registration fees are not refundable if a player is dismissed from a game or the NRSC for any reason.
